Description of Complaint The Principal of Volcano Vista High School, in Albuquerque Public Schools, sent an electronic communication in her official capacity as the principal to all parents using public resources directing parents and "VV families" to vote "YES" on a special bond election. This list is composed of over 3,500 recipients. According to the APS Technology Acceptable Use Policy, "promotion of one candidate or position over another is not allowed". This public employee is clearly asking for votes in a special election.
